Introduction from the Chair

The Chair thanked all participants for joining the meeting. Mr. Littell welcomed new Directors to the meeting, Kenneth Payne (RI), Janet Coit (RI), Joe Martens (NY), Ken Kimmel (MA), and Patty Aho (ME).

Mr. Littell stated the Board will build upon the work conducted in 2010 to implement RGGI programs and continue preparations to support the 2012 program review

Program Updates

New Hires at RGGI, Inc.

The Executive Director provided an update on recent hires at RGGI, Inc due to staff turnover. Katie Ho was hired as Program Manager and Peter Rennee was hired as Business Manager.

RGGI COATS Security Update

Mr. Schrag briefed the Board on an additional comprehensive security review of RGGI COATS in response to recent attacks to the European Union (EU) registries. Mr. Schrag noted that unlike the EU registries all ten RGGI participating states use a single, common registry for all CO₂ allowances, with a single system administrator and set of operational procedures. Mr. Schrag stated that RGGI Inc. and SRA were making security enhancements to the RGGI COATS systems and operational procedures on an ongoing basis.

RGGI Inc. Corporate Documents

Mr. Schrag announced that several RGGI Inc. corporate documents such as the Board minutes, Executive Committee minutes, annual budgets and additional operational documents policies were released on the RGGI, Inc. website. Mr. Schrag stated that the release was approved by the Executive Committee to better inform the public on program best practices and procedures.

Update on February 23-25 meetings

Ms. New provided an update on the upcoming 3 Regions meetings to be held in Washington, DC.
